About the Eastern Kentucky Business Park

The Eastern Kentucky Business Park has 180+/- acres of industrial land available. The park is located adjacent to four-lane KY HWY 3; connects to four-lane US 23 and Interstate 64.

- Can accommodate heavy and light industrial manufacturing operations
- Phase 1 Environmental available
- Within 30 minutes of the Martin County Area Technology Center, three KCTCS campuses and the East Kentucky Advanced Manufacturing Institute
- 670,000 gallons per day of water available; 600,000 gallons per day of excess sewer capacity
- Redundant power available from two AEP - KY Power substations

The Martin Industrial Building is a 55,000 SF metal on steel frame building situated on 30+/- acres and is located adjacent to the Big Sandy Regional Airport. All utilities are available at the building.

Features

- Floor area: 55,000 SF; expandable up to 100,000 SF with additional Detailed Development Plan approval on current 30-acre site
- Dimensions: 250' x 200' (plus 5,000 SF of finished office space)
- Ceiling Height: Min: 24' Max: 32'
- Floor: 7" reinforced concrete floor
- Walls: 24-gauge, 2" thick insulated sandwich panels and 8' block wainscot with core insulation
- Column Spacing: Two rows with 60' x 25' spacing
- Docks/Overhead Doors: Two drive-in doors and two dock doors installed; expandable
- Overhead Cranes: Three Overhead Cranes; Two Five Ton and One Seven Ton
- Parking Spaces: 32 (expandable)
